On 9th November 2016 the Commission of the European Union presented the progress report 2016 on the development of Albania as an EU-candidate for accession. The Commission recommends its member states to start accession negotiations with Albania. What are the requirements and perspectives for politics and the economy? - This is the question addressed by the Albania Forum, to which the German-Albanian Economic Association together with the Embassy of the Republic of Albania in Berlin invites to an economic forum on the occasion of the Albanian national day. The Forum will be held on Monday, 28th November 2016, at Deutsche Bank AG, Unter den Linden 13-15, 10117 Berlin, from 4:00 pm to 6:30 pm, with the possibility of deepening the discussions afterwards.
